Looking and Feeling FAB, Inc. provides comfort and relief to those with cancer, through integrative therapies, alleviating side effects and improving quality of life. We are a nonprofit 501(c)(3) Public Charity that employs licensed Aestheticians and Massage Therapists who are Oncology Trained. We use safe chemical free products, combatting skin side effects such as rashes, burns, itchiness, redness, severe dryness, scars etc. that develop from surgery, chemotherapy, radiation and non cancerous medications. Our charity was founded by a local Aesthetician, Holly Brown, who underwent chemotherapy infusions for Multiple Sclerosis and Sarcoidosis and saw how it damaged her skin. ## ***How the Program Works***

Those wishing to apply must fill out the application and have the medical release form signed by a medical professional. Once completed, client should call to schedule first appointment. 1st treatment will be 1/2 hr history intake, 1/2 hr treatment and client will receive a FAB kit of products. The client is then entitled up to 4 complimentary treatments, choosing between facial or massage. An educational session on a varied number of important topics is also included. Participants are encouraged to continue with reduced cost treatments when complimentary ones have ended.
